"Children" – a key concept meant to describe an analytical framework in which people have contingent ambitions at the cost of the de facto deprivation of a wide range of citizens' rights, at the junction of rich and poor, the privileged and disadvantaged in a transnational space.

The challenge of this conference is to find an analytical framework that illustrates the circumstances of the left-behind children of migrant domestic workers, "parachute kids" of satellite families, children of multi-cultural or fluid families with multiple affiliations, and invisible children with refugee/stateless status.


